TIMING TRANSPONDERS: Any competitor taking part in official qualifying and/or a race without his/her transponder in position will be deemed to be a non-starter, unless there is a valid reason. Timing transponders are to be returned to the timekeeping officials prior to their leaving the circuit (i.e. within one(1) hour of the last race finishing). Transponders not returned by this time are to be returned by no later than 16h00 on Monday following the race meeting to Charmaine Haupt at address Annex 115, Milnerton Medi Clinic, Milnerton, Cape Town (Ambutek Training College) by hand delivery and not courier. No further transponders will be issued to the competitor concerned until such time as the transponder has been returned and the levy paid. If the transponder is lost or broken the competitor is liable to pay the value of the transponder at that point in time. No further transponders will be issued to a competitor concerned until such time that the transponder levy is paid. Once the levy is paid, the lost/broken transponder belongs to the competitor concerned.

11. ENTRANT'S LICENCES:

Where the entrant is NOT the rider, an entrant's licence must be obtained from MSA and submitted together with the entry form, failing which the Entrant's name will not be published in the programme. Refer to ART 4 of the 2018 MSA SA National Enduro SSR's.

National E1 (200cc)	Open to riders from their 16th birthday and older (Two-stroke: 125 to 200cc and Fourstroke: 150 to 250cc)
National E2 (Open)	Open to riders from the year of their 18th birthday and older (Two-stroke: over 201cc and Four-stroke: over 251cc)
National Senior	Open to riders from the year of their 36th birthday and older. The class will be open to any capacity motorcycle, applicable to 200cc and open classes. The organisers shall decide on a shorter distance, which will be as close to 75% of the full National class distance, as practically possible.
National High School	Open to riders from the year of their 15th birthday, to 31 December of the year in which their 18th birthday occurs. Maximum capacity motorcycle of 125cc. The organisers shall decide on distance to be run, which will be a minimum of 50% and maximum of 75% of the full National class distance.
National Masters	Open to riders from the year of their 46th birthday and older. The class will be open to any capacity motorcycle applicable to 200cc and open classes. The organisers shall decide on a shorter distance, which will be a minimum of 50% (or a maximum of 2 racing laps) of the full National class distance.
Silver Interprovincial Challenge	Open to riders with regional only. Any capacity motorcycle. The organisers shall decide on a shorter distance, approximately 75% of the full National class distance.
	The Silver Interprovincial Challenge Series winner may not re-compete in the class. And the winner of the previous year's Silver Interprovincial Challenge class will be entitled to free entries in a National class in the following year.

14. POSTPONEMENT, ABANDONMENT OR CANCELLATION:

The Organisers reserve the right to cancel the event if less than 100 entries have been received by the closing date.

The Organisers reserve the right to postpone, abandon or cancel the meeting or any part thereof. In the event of any of the above, the Competitor/Entrant has no right to claim against the Promoter/Organiser in respect of any loss or damage he/she may incur, other than that specified in GCR 244. The meeting will not be postponed, abandoned or cancelled without the consent of the Clerk of Course in accordance with GCR 152.

15. ADVERTISING:

It is condition of entry that in addition to the advertising referred to in GCR 246, competing motorcycles shall also display the advertising, if any, as stipulated in the Championship and specifications for the class for which the motorcycle is entered.

16. POINTS:

Points will be scored as per Art 7 in the 2018 MSA SA National Enduro SSR's.

17. PROTESTS:

All protests and appeals will be dealt with as set out in GCR Appendix R, Parts IX and X.

18. RIGHTS OF THE CLERK OF COURSE:

The Clerk of the Course and/or the Stewarts of the Meeting have the right to call a halt to an event due to "force majeure" for any of the following, but not limited to, reasons:

- i) Extreme weather conditions
- ii) Serious or fatal accident
- iii) Sections of the route being deemed impassable owing to recent extreme weather or other unforeseen circumstances.
- iv) Dangerous circumstances for riders involving spectators or bystanders.
- v) Any other circumstances which the Clerk of the Course, in his sole discretion, deems to be dangerous or prejudicial to competitors.

19. CROSSING OF PUBLIC / DISTRICT ROADS:

As the organizer we have fully acquainted ourselves with Art 20 of the 2018 MSA SA National Enduro SSR.s

We the organizers are also aware and have acquainted ourselves with the provisions of Section 317 of the Road Traffic Act and confirm that the event officials have been made aware of the above section. By allowing the event to proceed we accept that all requirements are complied with and where applicable all relevant permissions are in place.

20. GENERAL:

- -Safety Plan for the event will be available from the Race Secretary, as per the requirements of the Safety & Recreation Act 2 of 2010. Written permissions and Police Clearance Certificate will also be with the race secretary.
- Every pit is required to have a Fire Extinguisher of at least 2.5kg capacity.
- Every rider is required to use an Environmental Mat when refuelling
- Failure to meet these requirements will result in a fine being imposed







- Refuse Bags will be available at The Registration Table
- Riders are expected to take their refuse bags with them when leaving
- Riders to carry rope, whistle, cell phone, Minor Repair Kit, Water, Nutrition and Sun Block.
- -Bring additional WATER along due to the water restrictions in the WC.
- -NO PETS ALLOWED AT VENUE
- -NO CAMPING IN PITS; THERE IS CAMPING FACILITIES AT THE VENUE
