A.

Your application for risk categorization received has bearing.

The Richmond WFO Regional Enduro Event that is scheduled to take place at Mkobeni Farm in Richmond on 29 August 2020 is categorized as Low Risk.

LOW RISK EVENTS

In Terms of Section 4(9) of the Sports and Recreation Events Act 2 of 2010, the Event Organizer for the event categorized as Low Risk ensure the following:-

- A Safety Officer is appointed for the event.
- A Written Safety Plan is prepared detailing event:
 - o safety measures
 - o security measures
 - crowd management measures
 - o motor vehicle parking arrangements and
 - o emergency medical measures including participant medical measures as contemplated in the national Health Act
- The above measures are put in place.

- The local police station is informed prior to the event of the event details.
- The local bylaws must be observed and any other relevant Regulations and Legislation.

RESTRICTIONS IN TERMS OF COVID ALERT LEVEL 3

- Suitable arrangements must be made that the event can take place in a safe and responsible manner in the Covid-19 environment as stipulated in the permission letter from the Minister of Sport, Arts and Culture.
- As per Alert Level 3 Regulation 37(1)(e), no other person than those mentioned are allowed to attend the event. The persons that may attend are players (drivers / riders), match officials, journalists, medical and television crew. (No spectators will be allowed).
- Should the organizers allow persons other than those mentioned in Regulation 37(1)(e) to attend, it will constitute a prohibited gathering under regulation 37(1).

You are requested to ensure that a copy of the safety plan is presented to Captain Scheepers (079 5000 964) of Richmond SAPS on or before 26 August 2020.
